The Neskowin Community Association is excited to present three Neskowin U classes this year.

Flower Containers 101, June 25 at 3:00 pm at NBGC clubhouse. Cost \$20

Have you walked around Neskowin and admired all the potted flowers? I know I have! Our first class will be taught by our very own flower specialist, Connie Leben. Connie will guide you in choosing flowers, designing and planting your container. Please bring your own container and gloves. We will supply the soil and flowers for you to create your beautiful flower container. Tuition for this class includes a beverage. If you forget to bring a container, we will have a couple spare containers on hand for purchase at additional cost. Sign up early. Limited spaces available.

<u>Pilates Saturday, July 23 at 10am at the NBGC clubhouse.</u> Cost \$10

What is Pilates you might ask? This question will launch a discussion and exploration of the Pilates method with movement specialist Jill Spangler. Picture the human body as a suspension bridge. Time, outside forces, and damage (injury) adversely affect the bridge's components. Some of the support cables may shorten for example, while opposing cables will lengthen and create a less efficient and sound structure. Without proper care and maintenance, the bridge will weaken and perhaps fail. During the class we will explore this concept and gain insight into how movement practice can help bring our internal suspension bridge into a more balanced state. Standing and seated alignment will be explored as well as supine, prone, and side lying positions. This is a beginning level class and individual exercise modifications will be given as needed. Please wear comfortable, elastic-waist bottoms and tops without buttons, zippers or adornments (think comfy pajamas or yoga attire). Bring a hand towel and yoga mat.

<u>Tsunami Planning / Go Bags, Date to be determined.</u> This class is free.

Knowledgeable team members from the South Tillamook Emergency Volunteer Corps will share with Tsunami Safety and the importance of having a plan and Go Bag. They will offer Go Bags for sale the day of the class. Please keep an eye on the NCA website for the date of this informative class.

Neskowin's Emergency Egress Completed

On Tuesday, May 24, Tillamook County Public Works and the Nestucca, Neskowin, Sand Lake Watersheds Council hosted a ribbon cutting for the Neskowin Emergency Egress. Speakers included County Commissioners Erin Skaar and David Yamamoto, State Representative David Gomberg, former county commissioner Mark Labhart, and County Public Works Director Chris Laity. Ran Koch and Robin Crowell spoke briefly on behalf of the Neskowin CAC and NCA respectively.

As part of the ceremony, several people and agencies were recognized for their contributions to getting this project done. A list of donors is posted on the south gate, which includes a community fundraiser that contributed \$100,000. The Walton family of Neskowin was recognized for donating the land for the road and Chuck Carlbom was remembered for his early persistence in getting the road built.

The process that led to the construction of the emergency egress was a long one. In 2009, at the request of the Neskowin CAC, a committee was formed, chaired by then County Commissioner Mark Labhart, consisting of experts on coastal hazards and local community members with the charge to help Neskowin be more resilient to coastal hazards. One result of that work was the recommendation to locate and build a second access to the village, one that meets current 100-year flood standards and one that is not threatened by a failure of the Salem Street Bridge. The site of the new access was identified as the best option. After a land donation by the Walton family and successful negotiations with Oregon State Parks for access to the Wayside, construction planning began.

The permitting and engineering challenges presented by road construction through a wetland, adjacent to a federal refuge, and across two creeks with critical fish passages for endangered salmon, were significant. Thanks to a persistent effort from County Public Works and the cooperation of various federal and state agencies, planning was completed. Construction began last fall and is now complete!

The emergency access is built to a 100-year flood protection level and includes three major fish passage bridges and culverts that provide access for endangered salmon. Its primary purpose is to provide a second access to and from the village in case of disruption at the Salem Street Bridge. When not in use for emergencies it may be used by pedestrians and bicyclists.

Scotch Broom - Neskowin has been invaded!

Lurking in the soil, brandishing in open spaces, hiding in plain sight. Scotch broom, also known as Scot's broom, is a noxious, invasive weed that costs Oregon \$40 million per year in lost timber revenue and control efforts. Its oil fuels fires -- especially along highways, in power line corridors, and dry forests.

Seed pods from Scotch broom dry out, twist and pop open, dispersing up to 12,000 seeds a year that can survive up to 30 years in the soil, waiting for soil disturbance to stimulate growth. Plants can grow from crowns after clipping, frost or fire. Prevention is important. Growth of Scotch broom is slowed by revegetating disturbed areas with fast-growing native trees, shrubs, and native grass mixes.

If you find Scotch broom, the OSU extension recommends:

- Dig it up, including the crown.
- Cut it back to the ground below the crown each year before it sets seeds. Dispose in garbage.
- Keep an eye out for seedlings each spring. Pull them up, roots and all, while they are still small.
- Herbicides are <u>ineffective</u> when Scotch broom is in bloom. Avoid herbicide use near native plants, creeks, runoff areas and other waterways. We all can slow the invaders!

Wildfire Information

Oregon has an evacuation notification system:

Level One, coded green, means BE READY to evacuate. Older adults, families with children, people with disabilities, livestock and pet owners, and those with limited access to transportation should consider evacuating at Level One.

Level Two, coded yellow, means BE SET to evacuate. There is significant danger in the area and people should be ready to leave at a moment's notice. Voluntary evacuation at Level Two is recommended, especially if people need extra time or have livestock.

Level Three, coded red, means GO NOW – Leave Immediately! Level three indicates there is extreme danger in the area and remaining threatens the safety of individuals as well as emergency responders, who may not be available to help those who choose to stay. Do not stop to gather belongings or protect the home. Now is the time to act. Grab your go bag and go.

The Oregon Office of Emergency Management urges Oregonians to evacuate any time they feel unsafe, as conditions can change rapidly. Individuals should always make the best decision for their safety. Following an evacuation, people should not return to the area until public safety officials announce it is safe. For more information on wildfires go to: wildfire.oregon.gov.

Neskowin Citizen Advisory Update

The Neskowin Citizen Advisory Committee (NCAC), a function of the Tillamook County Planning Department which provides a voice for our unincorporated community on Land Use Planning issues, has been active this spring.

Continuing efforts to address the community's concerns about how to best manage Short Term Rental (STR) activities in our neighborhoods, the NCAC created a Sub Committee composed of members of the community from different perspectives. Owners of a business, full time residents, STR owners, part-time residents, the Sub Committee developed a survey and over 400 Neskowin folks participated in the survey.

Results are still being processed by the group and there will be a public meeting in late June to share more results of the survey and provide what people think are issue and values related to STR's. For updates please visit neskowincac.org.

Neskowin is also in the process of revising its Community Plan which is what the County Planning Dept. and Commissioners refer to when making Land Use decisions in our community. The 1999-2000 Community Plan is our current functioning Community Plan until the revisions are completed and approved by the County.

Over the past year the NCAC has held monthly Informational Town Halls (ITH's) to inform folks about the State Planning Goals, Firewise practices, Acquisition of the Neskowin Watershed for safe and dependable drinking water, and those recorded ITH's are available on the website for your review and education. Please visit neskowincac.org.

A survey of all property owners, residents and business owners will be distributed this fall for initial responses to help guide revisions. Public Meetings and exact revisions will follow as we work together to create the revised Plan.

The NCAC also works with the NCA (Neskowin Community Association) to address safety concerns for Neskowin, and will soon be addressing safety concerns on Hwy 101 with Oregon Dept. of Transportation for a crosswalk, possibly a periodic blinking light and signage to slow traffic coming both north to south and south to north, especially during Farmers Market hours.

Garbage Containers at Mt Angel and Carlton – No Household Trash or Waste

In response to the increasing numbers of day trippers and beach visitors, the Neskowin Community Association arranged for garbage containers at the beach access points on Carlton and Mt. Angel during the summer season. These garbage containers are intended for beach trash and debris that otherwise might be left on the beach, or scattered around the village, or piled up at the wayside.

NCA's agreement with Nestucca Valley Sanitary Service specifies these garbage cans are not to be used for household trash and waste. Neskowin homes, whether owner-occupied or short-term rentals, must provide for their own trash removal.

The service provider recently notified NCA that household garbage, empty plastic plant containers and other household waste has been found in the containers at Mt. Angel and Carlton.

Please respect our agreement with the service provider and stop placing your household garbage in these containers. Thank you.
